### **Prevention**

#### **Progressive prevention initiatives**

aiming to prevent crime by addressing its root causes are a cornerstone of the NWDAO's guiding principles. The office works in partnership with community groups to help people from youth to elders as well as schools and youth-serving organizations.

#### **The Consumer Protection Unit**

mediates consumer complaints about fraudulent or deceptive business practices and educates the community to have better informed residents be able to identify scams.

TRIAD aims to reduce victimization of elders through education and connection. TRIAD is a cooperative effort of the NWDAO, the Hampshire and Franklin Sheriffs' offices, local police departments and councils on aging.

NoFIRES, or Northwestern Fire Intervention, Response, Education and Safety, is a collaboration among NWDAO, law enforcement, fire departments, and human service agencies to respond to youth who set fires or engage in other fire-related behaviors.



Prosecutors seek alternatives to convictions and incarceration though diversion and restorative practices with juveniles and adults. The office is steadfast in its focus on addressing the root causes of crime, helping people who struggle with addiction and working to fight stigma.

## **Investigation and Prosecution Units**

Northwestern Assistant District Attorneys work with law enforcement to ensure effective, ethical investigations and prosecutions.

State Police detectives assigned to the office investigate major felonies and other serious matters. The Northwestern District Anti-Crime Task Force, made up of State Police detectives working with local police departments, investigates human trafficking, homicides, drug trafficking and more.

The Domestic Violence and Sexual **Assault Unit prosecutes cases** involving family, partner and household violence and adult sexual assault, with special attention to protecting victims. The unit advocates for best practices to prevent domestic and sexual violence.

**The Child Abuse Unit prosecutes** offenders and supports child victims. ADAs and family service advocates are specially trained in the unique needs of child victims, balancing prosecution with trauma-informed approaches to help victims on a path towards healing.

The Juvenile Justice Unit seeks to reduce youth violence and crime through prevention, early intervention and diversion, working with schools to keep youth out of the criminal justice system whenever possible.

Victim/Witness Advocates support victims and witnesses to crime by following the Massachusetts Victim Bill of Rights. Advocates guide victims through the criminal justice process and in finding resources for safety and healing.

The Elders and Persons with Disabilities Unit investigates and prosecutes crimes against elders and people with disabilities, working with communities and adult protective services to protect the most vulnerable people from harm and exploitation.

## **Community Partnerships**

Collaboration is a hallmark of the Northwestern DA's office as staff forge connections with people in the district to address social issues that interfere with thriving and healthy communities.

The Veterans Justice Partnership, created in 2011 by District Attorney Sullivan working with other community leaders, helps court-involved and incarcerated veterans. providing services to improve their lives. The Western Massachusetts Veterans Treatment Court was developed out of the belief that those who dedicated their lives to their country deserve second chances and support when they fall on hard times.

The Children's Advocacy Centers in Northampton and Greenfield provide safe havens and trauma-informed responses to children and families in cases of alleged child sexual and physical abuse by bringing law enforcement, social services, health care providers and attorneys together to determine the best way to help children.

Understanding the role of addiction and substance use disorders in many people's involvement with the criminal justice system, District Attorney Sullivan takes a leadership role in the Opioid Task Force of Franklin County and the North Quabbin Region and the Hampshire **HOPE** opioid prevention coalition. The office works with youth substance use prevention coalitions to prevent early use of substances, better protect developing teen brains, and leads efforts to prevent drug misuse, promoting safe drug disposal through **drug collection kiosk**s and National Prescription Drug Take Back Days.
