WHAT IS A VETERANS TREATMENT COURT?

The WMVTC offers a voluntary, 24-month probation term intended to serve veterans struggling with mental health and/or substance use disorders. The program involves ongoing judicial and probation supervision with input from a multidisciplinary team of professionals. The Court promotes sobriety, recovery and stability through collaborations with VA and community-based treatment providers. In addition, all participants are matched with a volunteer veteran mentor who will assist them through the program.

WHO IS ELIGIBLE?

Eligibility is evaluated by the Veterans Court team on a case-by-case basis. General requirements include:

- Served in the U.S. Armed Forces
- Charged with a misdemeanor or felony in Hampden, Hampshire or Franklin County (has not been indicted) and eligible for probation
- Currently experiencing mental health and/or substance use disorders

WHAT ARE THE BENEFITS OF PARTICIPATION?

- Alternative sentencing options
- Access to a comprehensive treatment plan through the VA service system and/or community providers
- Vet-to-Vet peer mentor program
- A team of support and case management to help reduce any barriers to success.

WHAT IS THE PROCESS TO ENTER THE VETERANS TREATMENT COURT?

- Notify ADA handling case or Probation Officer on violation that client is a Veteran and interested in court
- 2. Complete referral form and submit to coordinator
- 3. VJO will confirm Veteran status of the client
- 4. The Veteran will participate in assessment to determine clinical eligibility
- 5. The Treatment Court Team reviews Veteran's legal and clinical eligibility
- 6. Veteran observes court session
- 7. Veteran reviews and accepts plea agreement with attorney
